



FMDQ Clear Limited Eligible Non-Cash Collateral – Q2 2026

The clearing risk activities of FMDQ Clear Limited (“FMDQ Clear” or the “Company”) for cleared products require that market participants pledge eligible non-cash collateral as margin collateral with respect to their open positions and credit exposure on executed transactions.

FMDQ Clear publishes the list of eligible non-cash collateral quarterly. Please see **Appendix 1** for the list of all eligible non-cash collateral effective from April 1, 2026. Kindly note that all illiquid non-cash collateral will attract an 80% haircut of the market value of the collateral.
